D. PRESENTATIONS AND PUBLIC INPUT

1. **Resolution No. 2020-06-031R**: Resolution of Affirmation of Ten Shared Principles (Illinois NAACP State Conference and Illinois Association of Chiefs of Police, Established March 22, 2018)

This item was moved from Additions to the Agenda.

Mayor Marlin introduced this resolution. She introduced Minnie Pearson, President of the Champaign County NAACP, Ed Wojcicki with the State Chief's Association and Robert Moore, Chairman for the Illinois NAACP Criminal Justice Committee. They spoke about the

purpose of Ten Shared Principles, which is to have the police department adopt policies to work with the community instead of against it, to replace mistrust with mutual trust of police, end racial disparities, and eliminate racial hatred and racial discrimination. Mr. Moore listed the Ten Share Principles:

1. We value the life of every person and consider life to be the highest value.
2. All persons should be treated with dignity and respect. This is another foundational value.
3. We reject discrimination toward any person that is based on race, ethnicity, religion, color, nationality, immigrant status, sexual orientation, gender, disability, or familial status.
4. We endorse the six pillars in the report of the President's Task Force on 21st Century Policing. The first pillar is to build and rebuild trust through procedural justice, transparency, accountability, and honest recognition of past and present obstacles.
5. We endorse the four pillars of procedural justice, which are fairness, voice (i.e., an opportunity for citizens and police to believe they are heard), transparency, and impartiality.
6. We endorse the values inherent in community policing, which includes community partnerships involving law enforcement, engagement of police officers with residents outside of interaction specific to enforcement of laws, and problem-solving that is collaborative, not one-sided.
7. We believe that developing strong ongoing relationships between law enforcement and communities of color at the leadership level and street level will be the keys to diminishing and eliminating racial tension.
8. We believe that law enforcement and community leaders have a mutual responsibility to encourage all citizens to gain a better understanding and knowledge of the law to assist them in their interactions with law enforcement officers.
9. We support diversity in police departments and in the law enforcement profession. Law enforcement and communities have a mutual responsibility and should work together to make a concerted effort to recruit diverse police departments.
10. We believe de-escalation training should be required to ensure the safety of community members and officers. We endorse using de-escalation tactics to reduce the potential for confrontations that endanger law enforcement officers and community member; and the principle that human life should be taken only as a last resort.

Ms. Pearson, Mr. Wojcicki and Mr. Moore answered questions and concerns from council members as discussion ensued.

Community Development Director Lorrie Pearson announced the small business assistance program, which offers assistance to local businesses that have been affected by the pandemic. Information is available on the website along with application and requirements.

Mayor Marlin read a statement addressing all residents of Urbana and to acknowledge the many calls by saying: we hear you, we are listening, we understand what you are saying, we all have acknowledged one way or another that this is a turning point in our nation's history and the calls for shifting resources to functions that can meet people's needs, defaulting to police to respond to needs has been much easier than addressing the systematic issues related to racial, social, and economic justices. Additionally, Mayor Marlin commits to restructuring the emergency respond and care system to a better plan that will address the needs of the people, especially those who are calling for help. Implementing a plan that will be sustainable while addressing mental health issues and reducing police contact.

I. NEW BUSINESS

1. [Ordinance No. 2020-06-035](#): Ordinance Approving the Fiscal Year 2020-2021 Annual Budget

Finance Director Elizabeth Hannan presented this ordinance. She started the presentation with an overview of all funds, which included the percentages for each department. She went over changes in the budget and corrections made because some errors were missed.

She explained the increase in the police department budget, saying police pension funding increased in order for the city to pay down unfunded liability. It was the largest part of the change in the police budget. It was suggested to extend discussion of the budget to another meeting in order to go into more depth.

CM Brown moved approval of Ordinance No. 2020-06-035. Motion seconded by CM Jakobsson.

Ms. Hannan informed council members that the budget would be revisited in the late summer or early fall because of the impact of Covid-19.

****Tuesday, June 23, 2020 at 5:30pm reconvened meeting.** There being a quorum virtually present, Mayor Marlin called the meeting of the Urbana City Council to order at 5:30pm.

Finance Director Elizabeth Hannan presented the changes requested by council members. Those changes included reducing salaries and benefits in the Police Patrol budget by 4% and removing the squad car for the K-9 unit from the Vehicle and Equipment Replacement Fund (VERF). The revised exhibit reflected a reduction in the General Fund of \$192,277. She said the reduction is roughly equivalent to two police officer positions.

Mayor Marlin told council members that the city made a conditional offer to a female for a vacant police officer position. An additional female officer would increase diversity in the police department. A 4% reduction in the budget would mean the offer would have to be withdrawn.

CM Brown moved to replace the original exhibit for Ordinance 2020-06-035 with the revised exhibit. Motion seconded by CM Miller. Discussion about the K-9 unit ensued. It was clarified that vehicle replacement was the only part of the K-9 unit to be eliminated.

Discussion about the 4% reduction in the budget continued, with clarification about the number of officers. Police Chief Seraphin responded to questions from council members. Mayor Marlin suggested the money saved from reductions should be earmarked for developing a new model for emergency response.

CM Jakobsson moved to make an amendment to the amendment of CM Brown, to decrease the 4% budget reduction to 2% and direct the savings toward the One Door

Policy planning and implementation, and keeping the current K-9 unit vehicle for another year. Motion seconded by CM Roberts.

After further discussion, the motion to approve the amendment to the first amendment was approved by roll call vote as follows:

My name is Alana Ackerman, I am a resident of Urbana. I would like to request that Mayor Marlin and the city council reevaluate and revise the proposed annual budget that is under consideration. According to some sources of information, 21% of the annual budget is planned to be allocated toward policing, while only 12% is planned to be allocated for community development. According to other sources, up to almost 33% of the general operating funds are set to be allocated toward policing, while only 5.2% of general operating funds are set to be allocated toward community development. Regardless of which set of numbers we are looking at, they are unacceptable either way. I know the city council wants to prioritize public safety; Mayor Marlin has stated this before. But public safety doesn't come from policing and from putting almost a third of a city's budget toward a system that we know is founded upon controlling and punishing Black communities and individuals. If you really want to make Urbana safer, if you really want to contribute to public safety, you do this by investing in people and communities. I don't know specifically what the city council means by community development. I think it would be good for the council to specify exactly what community development means, and what exactly the money would go toward. But again, either way we look at it, policing is not the answer. A budget is a reflection of a city's values. A budget reflects what a city wants to build up, wants to foster, and it also reflects what a city doesn't value, and what a city doesn't prioritize or consider important. What I see in this budget is disinvestment in communities, and I see the prioritization of the control and punishment of Black communities. I encourage the city council to reconsider and reevaluate its priorities, I ask that it listen to the people it represents, and I ask that it make the necessary changes to the proposed budget that the people of Urbana are asking for. Good evening,

On April 20th, Urbana City Council was asked to drop the charges against Aleyah Lewis. There is no state statute preventing you from publicly making such a recommendation. The non-response in this direction is indicative of systemic racism and corruption.

On April 27th, a presentation by Police Chief Seraphin described Cervantes losing his temper and breaking his thumb while assaulting Aleyah Lewis as professional. You were again asked to drop the charges against Aleyah Lewis. There is no state statute preventing you from publicly making such a recommendation. The non-response in this direction is indicative of systemic racism, corruption, and an abuse-enabling lack of rigor.

Again on May 4th, May 11th, May 18th, May 26th, June 1st, June 8th, and June 15th you were asked to drop the charges against Aleyah Lewis.

There is no state statute preventing you from publicly making such a recommendation. You found time to take photos of the Police Chief Seraphin for the Urbana Monthly News Letter at the George Floyd Protest and reappointed Chief Seraphin.

Maybe you should find time to follow Eric Jakkobson's lead and resign.

After reviewing the FY21 Proposed Budget, I was appalled to see how much funding was allocated to policing and how little was allocated to Community Development. The Urbana government has been hearing for months about the harm policing has caused in our community. This budget proposal feels completely out of touch with community feedback.

Urbana relies too heavily on law enforcement to address problems that should be addressed by a stronger social safety net. Investing in housing, food security, education, and mental health services could mitigate many of the problems that law enforcement is currently responding to. A budget that allocates 32.7% of funds to police will further perpetuate harm, particularly against Black communities and People of Color.

One major step to improving community well-being and safety would be removing School Resource Officers and reinvesting that funding in more mental health professionals. Increasing mental health professionals at younger grades has the potential to improve living conditions, connect families to resources, and interrupt the school to prison pipeline.

I also ask that the City Council look beyond incremental defunding of law enforcement and imagine a community entirely without police. This is not an impossible dream- the Urbana community has the resources, creativity, and passion for human rights to pull it off. We could stop funneling individuals into an inequitable court system and instead provide opportunities for non-punitive restorative and transformative justice.

When I look through the jail bookings and see "driving on a suspended license", I know this typically means that its Men and women who are behind on their child support and who get arrested. With a charge against them, they still have to work. Maybe they choose to drive and get pulled over again. They are in the tangled web of the court system, paying fines, with a charge added to their record and all the while they are trying to catch up with their child support. Why is this a punishable offense that they need to be in jail for? Its not right, and we all see what's going on. We are paying for guardians, and that's what I want.

Cops now have the nicest and smoothest undercover cars. We need to be able to see you if we need help, so how is having an undercover car or being undetectable helpful to the community?

To sum everything up, Im upset with the unnecessary force and the unfairness of the system. As an RN all of my information is public. Any bad actions against my nursing license is public as well as my license number. All officers should have their information public as well.

Hello, my name is Arriel Phillips, and I am an RN and home owner in Champaign, Illinois. Like others, I too am concerned with the direction of the police force. I'm black. I'm concerned for my brothers, my father, my nieces and nephews, my friends and myself. As a Champaign citizen and tax payer I am uncomfortable with the idea of not making a change and continuing with what we are doing.

A few years ago, I was looking for a job and did a med pass at the county jail. I was horrified to see the proportion of black men vs white men. I left and immediately called my dad just to calm me down. That day I visualized a 75% ratio to 25%, easy. This isn't right and I'm sick of it.

I don't want to defund the police. I would like to move some funding. As a tax paying citizen, I don't want a military force protecting its citizens. We need more money put in to mental health. I worked as a psych nurse in Indiana, and it was shocking to see how many more resources there was for mental health there opposed to here.

When I look through the jail bookings and see "driving on a suspended license", I know this typically means that its Men and women who are behind on their child support and get arrested. My name is Chelsea Birchmier, and I have a couple of questions and a comment regarding the proposed FY 2020-21 Budget.

First, my questions: what steps did you take to ensure the budget and the date and time of this hearing reached as many citizens as possible prior to today? Were any efforts made to provide copies of the budget to people who do not have internet access or access to digital technologies? If you did not take these steps, what will you do to ensure that citizens have the chance to see and respond to this budget before it is approved? Additionally, I'm assuming public participation does not just mean that people will provide their input but that their input will actually be incorporated into the budget decisions that will be made. What is your process for using the input you hear today and that you receive by email to inform what the final budget looks like? Your answers to these questions are important because they tell me whether or not you value citizen participation. If you do not, then I believe that you are not performing your duty as an elected representative of the people.

Next, my comment: You are proposing to spend over \$11 million on the police, or 32.7% of the general operating fund. That is more money going to the police than to the fire department, to public works, or to community development, on which you propose to spend under \$1.8 million, or 5.2% of the general operating fund. We are in the midst of a global and local uprising calling for defunding the police so that money can go back to the Black communities that have been defunded over the years. In these times, how can you possibly justify a budget where more money goes to the police than any other area in the general operating fund? We, the citizens, pay the taxes that go to the general operating fund. If we say we want money to move from the police to the community, it is your duty to listen to us as our elected representatives. If you don't, I can assure you that the people will not allow business as usual to continue and that we will not forget if you choose to ignore our voices come election time in the spring.

I am writing again, to request that all charges against Aleyah Lewis be dropped, for a true, meaningful, and independent investigation be conducted, and while that investigation is underway the officers who beat Ms. Lewis be put on leave. I cannot believe that it has been over two months later this is still an issue the city council is discussing.

The police need to be held accountable for their actions. Ms. Lewis was at a safe distance from the officers and these officers already had the situation they came to deal with under control. It is unbelievable that the city continues to defend these officers after they engaged and beat a citizen who's biggest threat to these officers was that this citizen was talking to them. Even if they were yelling at these officers, the officers should have the restraint to allow that citizen to practice their first amendment rights and say whatever they want especially since again, she was at a large distance, not a threat, and was likely already shaken up and scared from the situation. Over the past few months, we have seen officers be faced with angry white Americans, yelling threats and waving guns around in officers' faces, and yet these officers stood their ground and no action by the police is taken against them. I am confident that had Ms. Lewis been white, these officers would have just left the scene. Stop defending racism in Urbana. This city has been showing how its citizens are demanding change, let this change start with these charges being dropped and a meaningful, independent investigation be conducted.

I'm also writing to voice that I am appalled to hear that Cheif Seraphin was re-appointed. It is beyond obvious that you Mayor Marlin went into this decision already made, that no matter what the people of the city that YOU ARE THE MAYOR OF had to say about this decision, you made your choice. Why do you continue to ignore the voice of the people?

Mayor Marlin you state that your "top priority is public safety, on our streets, in our neighborhoods, and in public schools" Why do you view the police as the only option for public safety? If we look at the history of the police, the reality is that they exist because slave owners wanted to stop slaves from running away. It is safe to say its foundation was for racist reasons and the racism seen within the police has yet to cease where over the last 8 years Black folx have experienced an INCREASE in the level of how vicious police treat Black folx.

So I get back to my question Mayor Marlin, Why do you view the police as the only option for public safety? Why do you put so much funding into the police when they don't even have the training to contribute to public safety? Here's an example of what I've seen public safety could be. Let's say someone witnesses someone behaving erratically and is in harm's way. Instead of calling 911, people could call a similar number which would lead them to connect with an urgent responder who could assess the situation. Now the person acting erratically could be met, by a trained psychologist) specializing in behavioral and mental health where they can ensure this individual get the care they need. Isn't that public safety? Sending someone who has over 150weeks of advanced educational training as opposed to being met with someone who has weapons and only 14weeks of general, non-mental health-specific training? This would be similar to what victims of domestic abuse or suicidal individuals would experience.

Why are you so hesitant to defund the police in exchange for a program that would actually address public safety which you continue to claim is one of your priorities?

If this city plans to move forward, it needs to reconsider the role of the police. At a minimum, the police need to be held accountable for their actions and should be demilitarized. Their job is to protect and serve the community, not protect and serve white people, and you don't need a militarized police to enforce laws or protect and serve the community. This city needs to start actually thinking about what is best for its citizens and how they can best help their citizens. Let's start that narrative now.
