2005 Annual Report

2005 was a very busy year for the Building Safety Division. The following reports show a significant increase in revenue collected over the previous year.

Total building safety revenue from all sources was **\$663.103**, which is a 20% increase over 2004. This is a **126%** increase over the **\$293,533** collected five years ago in 2001. The \$1,215,855 collected in the last 2 years is **\$139,224** more than the **\$1,076,631** collected the three years prior to 2004.

The total number of permits issued was 2,362. This is an increase of 47% over five years ago in 2001. Permits were down just 140 permits from 2004 and mostly reflect the decrease in single family residences from 155 in 2004 to 102 in 2005.

Total inspections performed were 4,983, which is just 117 less than 2004's record 5,100 inspections, and is 67% more than five years ago in 2001.

Housing inspection activity for 2005 is included in this report. The systematic inspection program of rental properties is ongoing after a 2004 restart. Area 19 was initiated in order to work on this problem area. A total of 580 units were inspected under the systematic program with 554 units cleared. This was accomplished while also doing regular complaints across the city and other important programs, i.e. certified housing, mobile home parks, fire department follow-ups and grants management program inspections.

Building Safety Division support staff has worked hard to keep up with the increased activity that is reflected in the increased amount of permitting and inspections necessary to keep the Division working. This increased workload by the inspectors also increased the amount of visitors and telephone calls for help and scheduling from support staff.

In 2005, the Building Safety Division oversaw the completion of inspections for such big projects as Holiday Inn Express, Stratford residences, Lincoln Square Village, Walgreens, and the January opening of Aldi's and Wal-Mart. The division looks forward to 2006, anticipating another busy year that will include a great number of inspections to finish the Carle Expansion project, the county nursing home, Capstone Quarters Condo's, O'Brien's move to the interstate, Lincoln Square Village, Carle Spine Center and Tatman's 5-Points Mall.

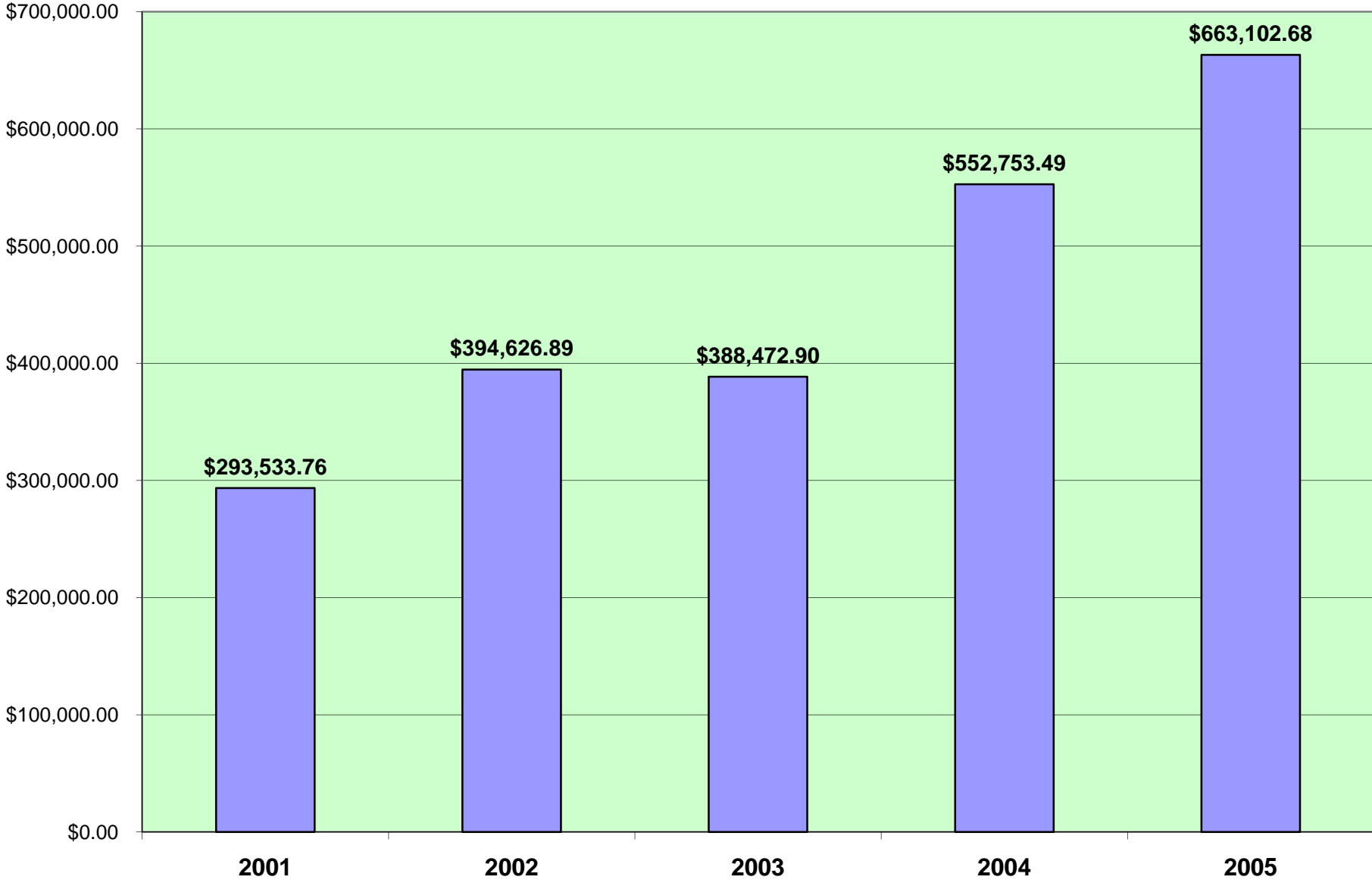
Also, numerous other projects will be starting, including the K-Mart/Creek Apartments.. Menard's developments, Gregory Place Phase 2, Wal-Mart strip center, Stillwater Landing Condo's, Prairie Winds Senior Living, continuing single-family homes in South Ridge, Savannah Green and Somerset II.

Staff is reviewing and preparing the ICC for adoption this year.

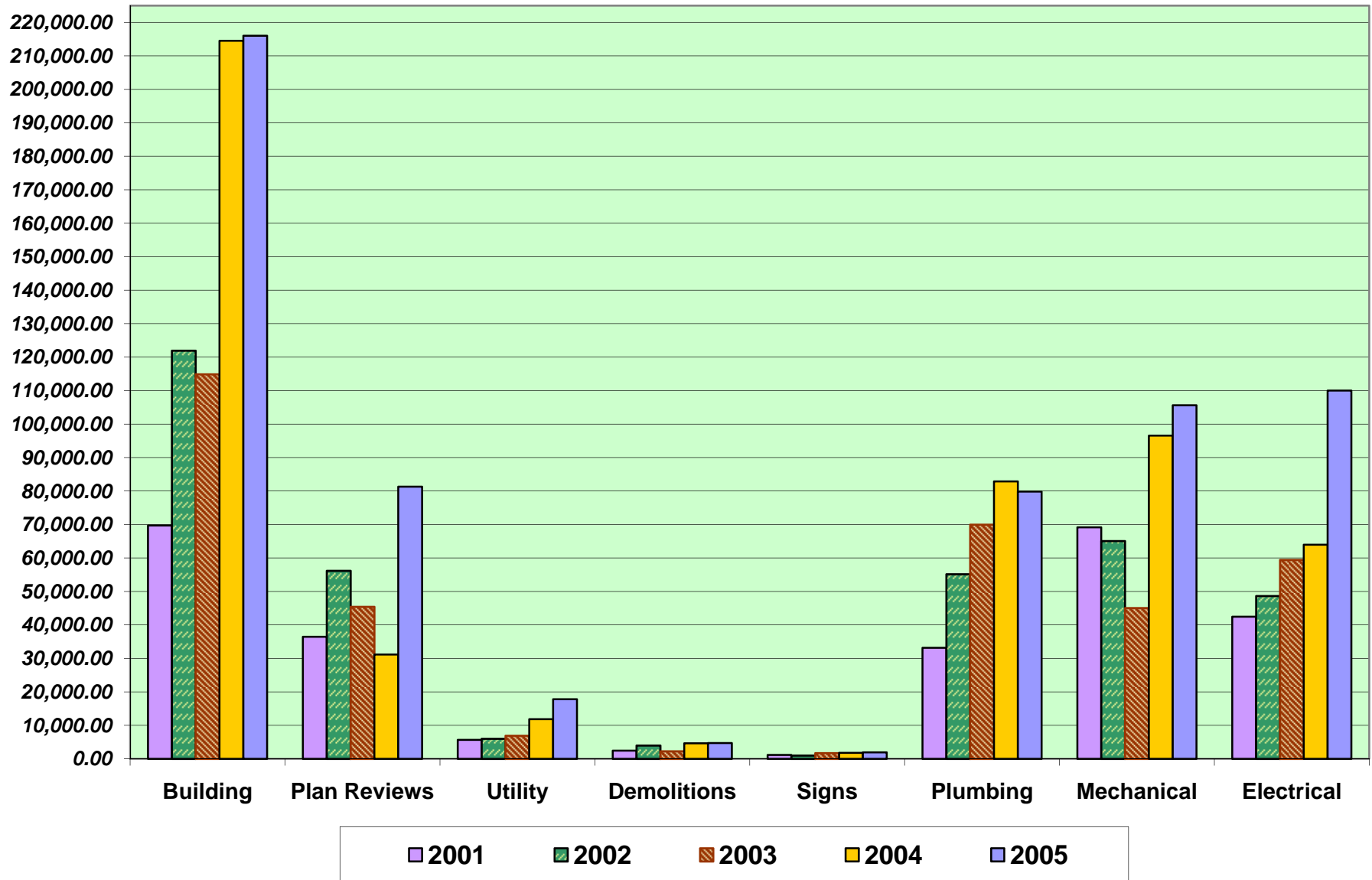
Building Safety Division is also helping to prepare a new rental housing registration program that will include the addition of another housing inspector and the increased ability to do systematic inspections of the City's rental properties for improved property maintenance.

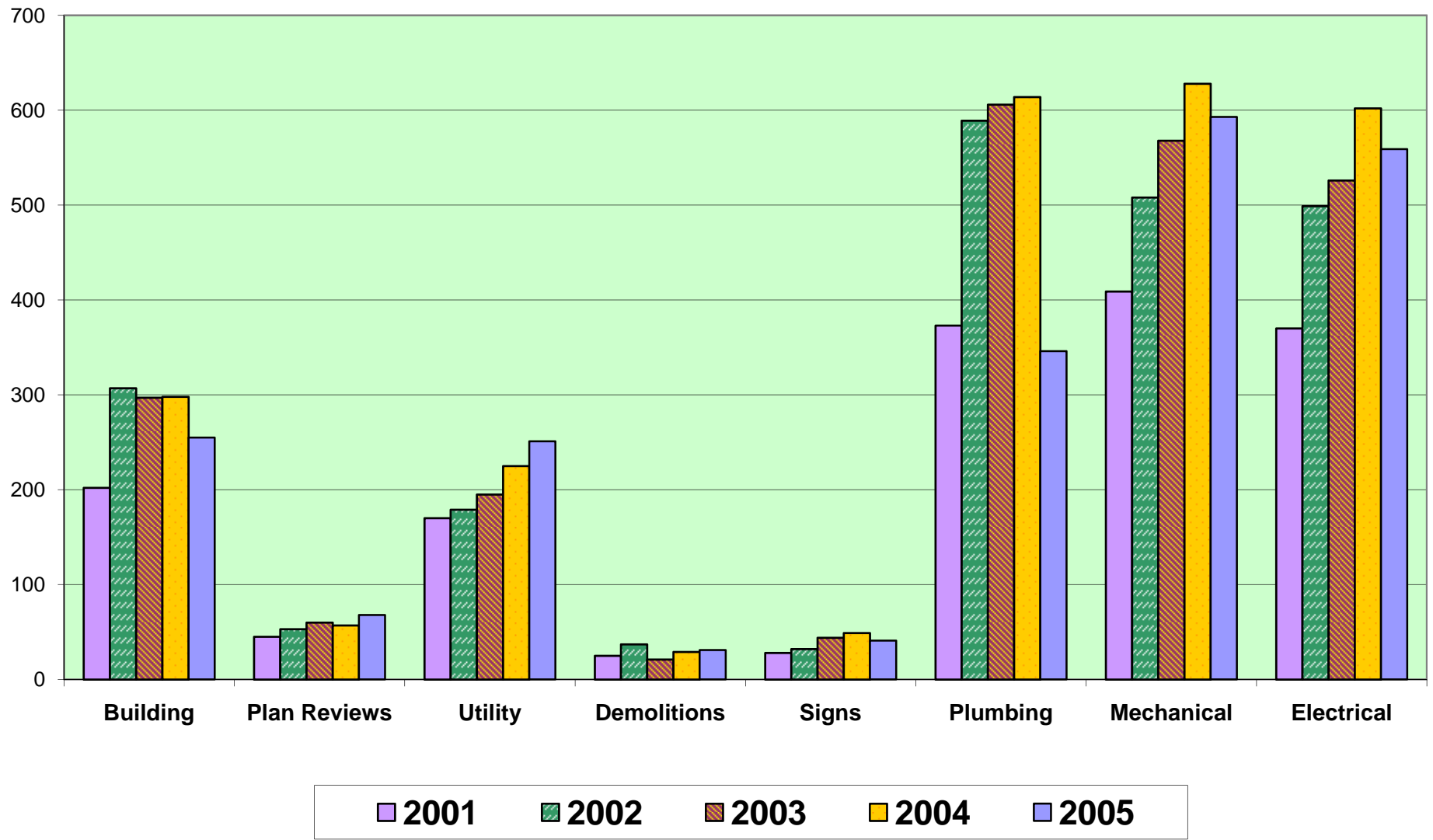

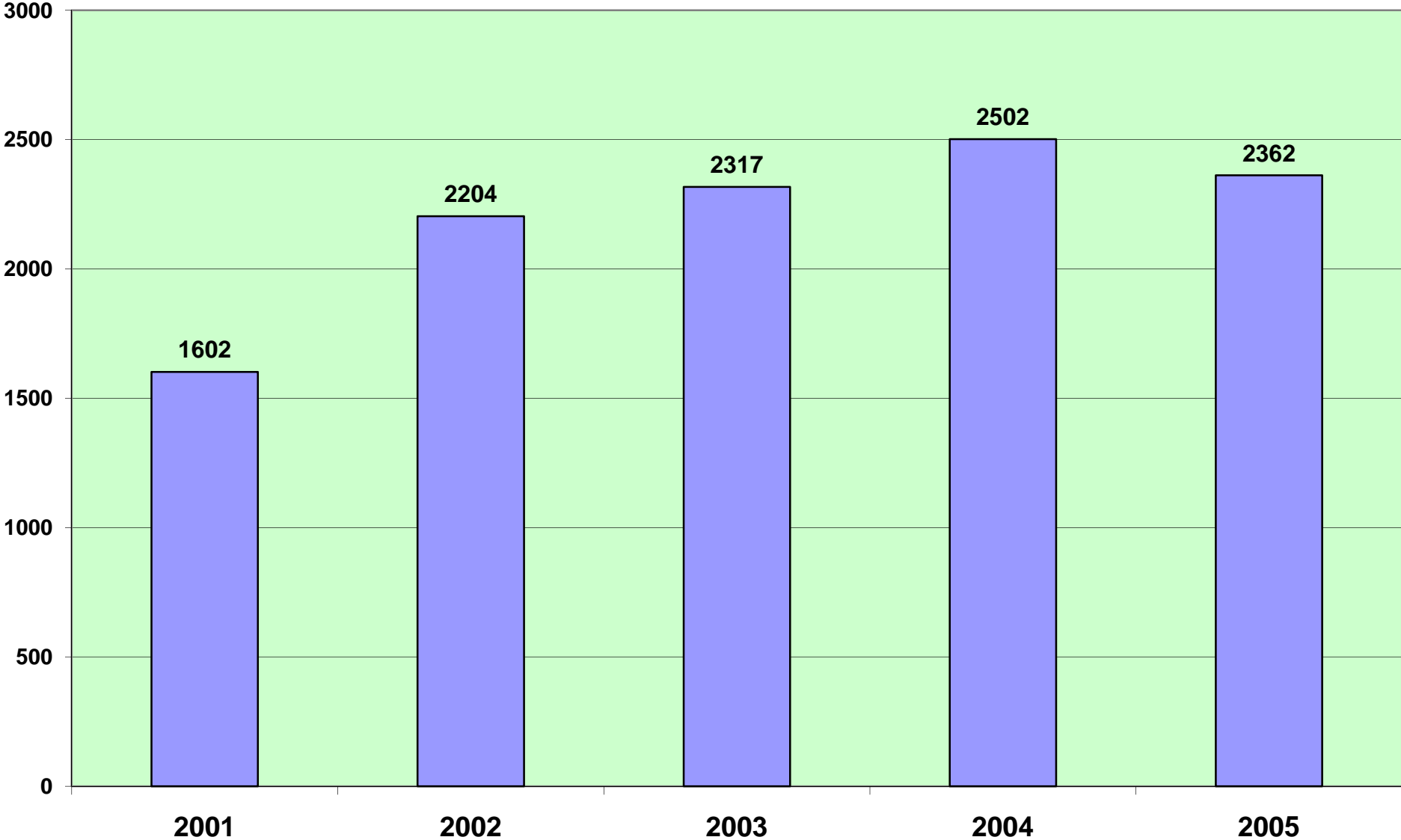

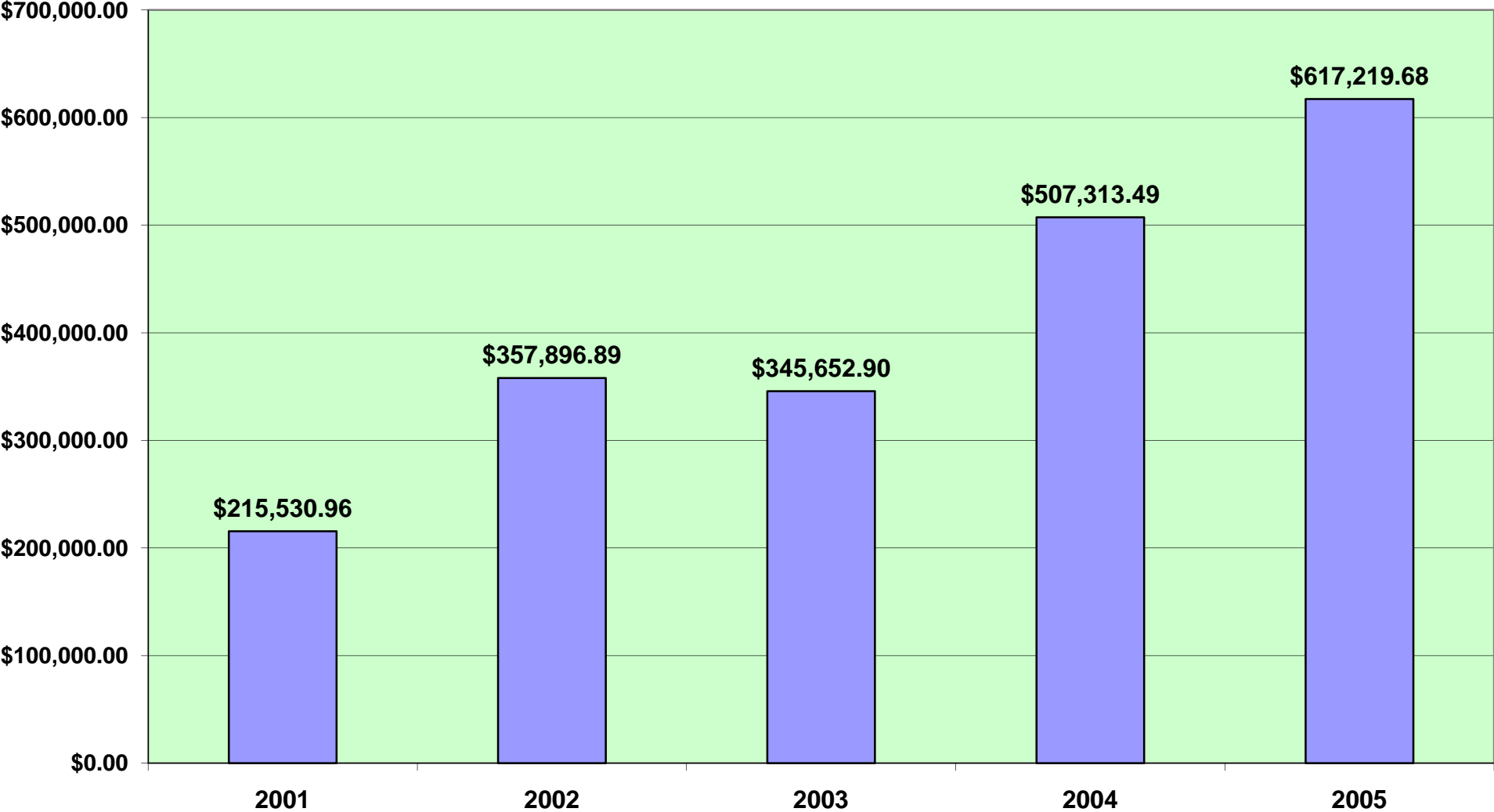
Total Permits 2001-2005



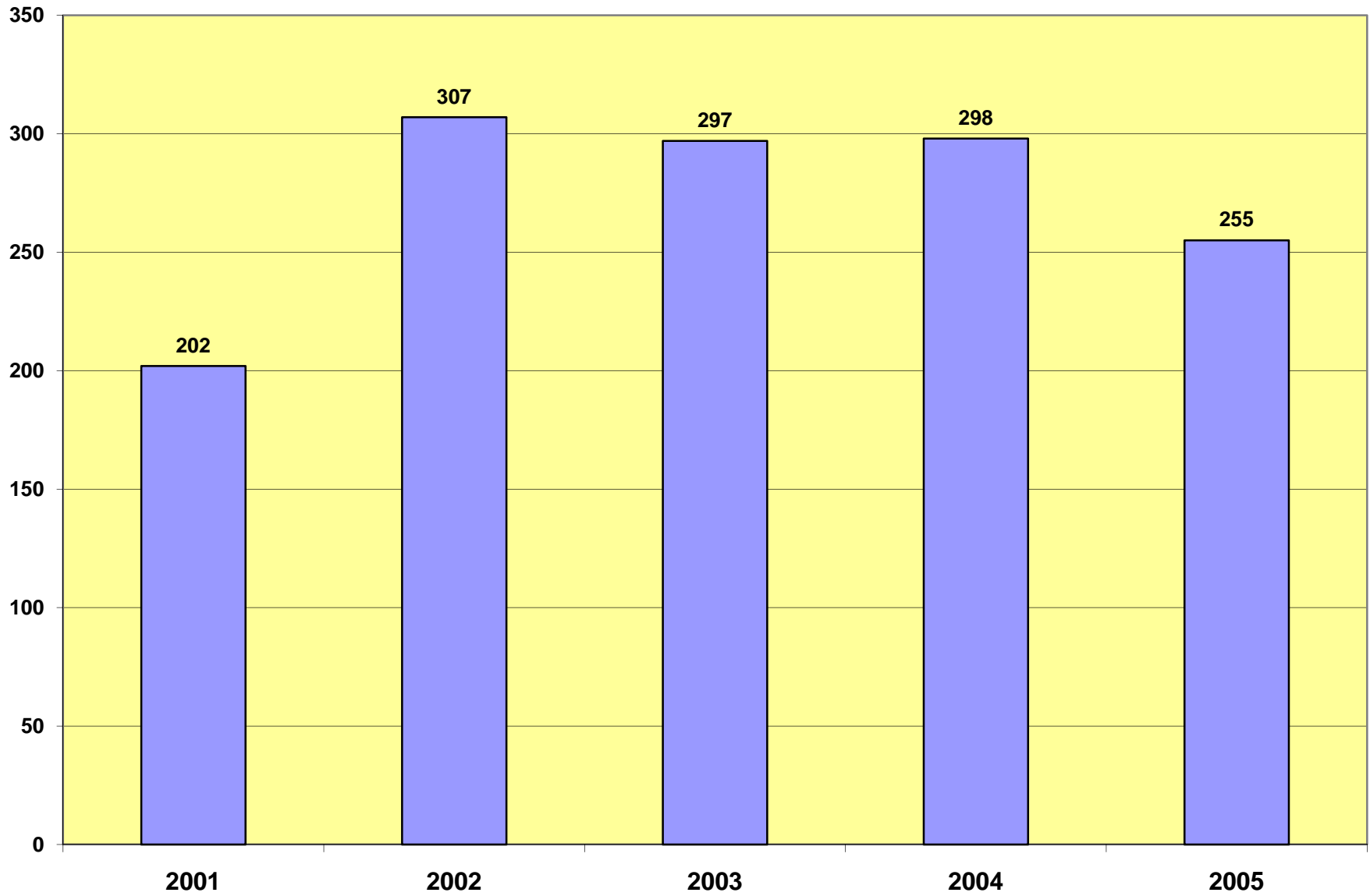
TOTAL NUMBER OF PERMITS 2001-2005



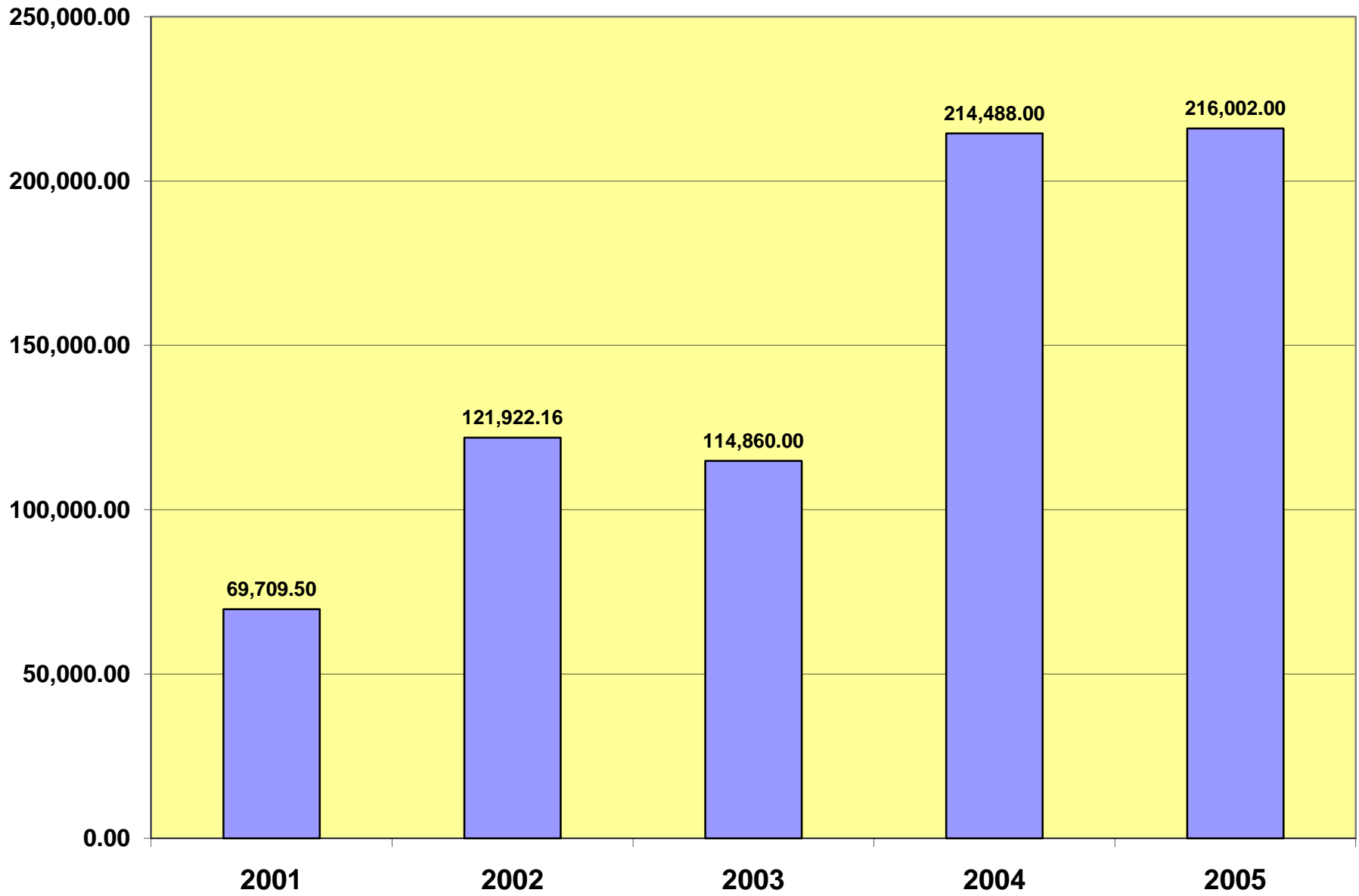
PERMIT REVENUE TOTAL 2001-2005



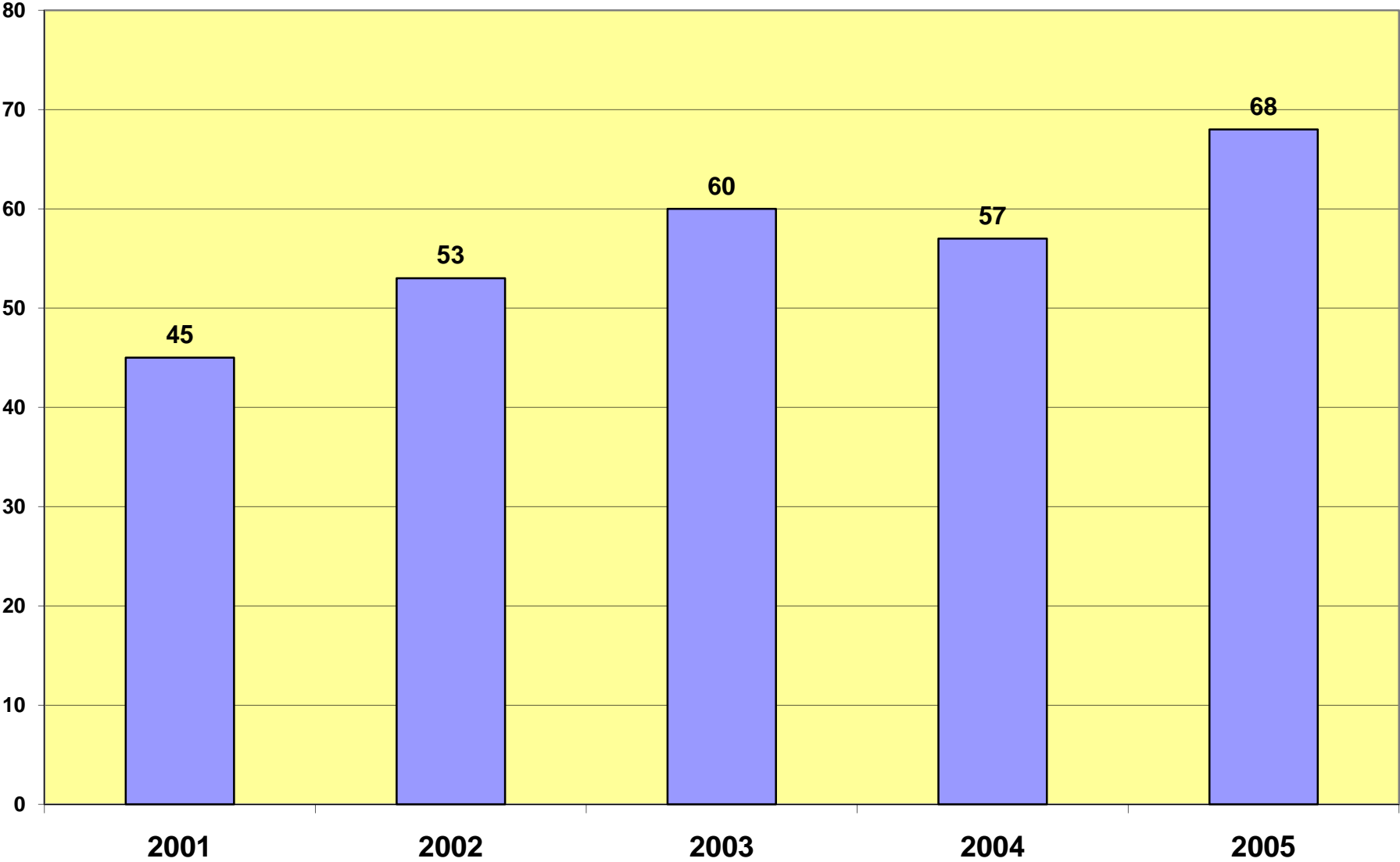
TOTAL NUMBER BUILDING PERMITS ISSUED 2001-2005



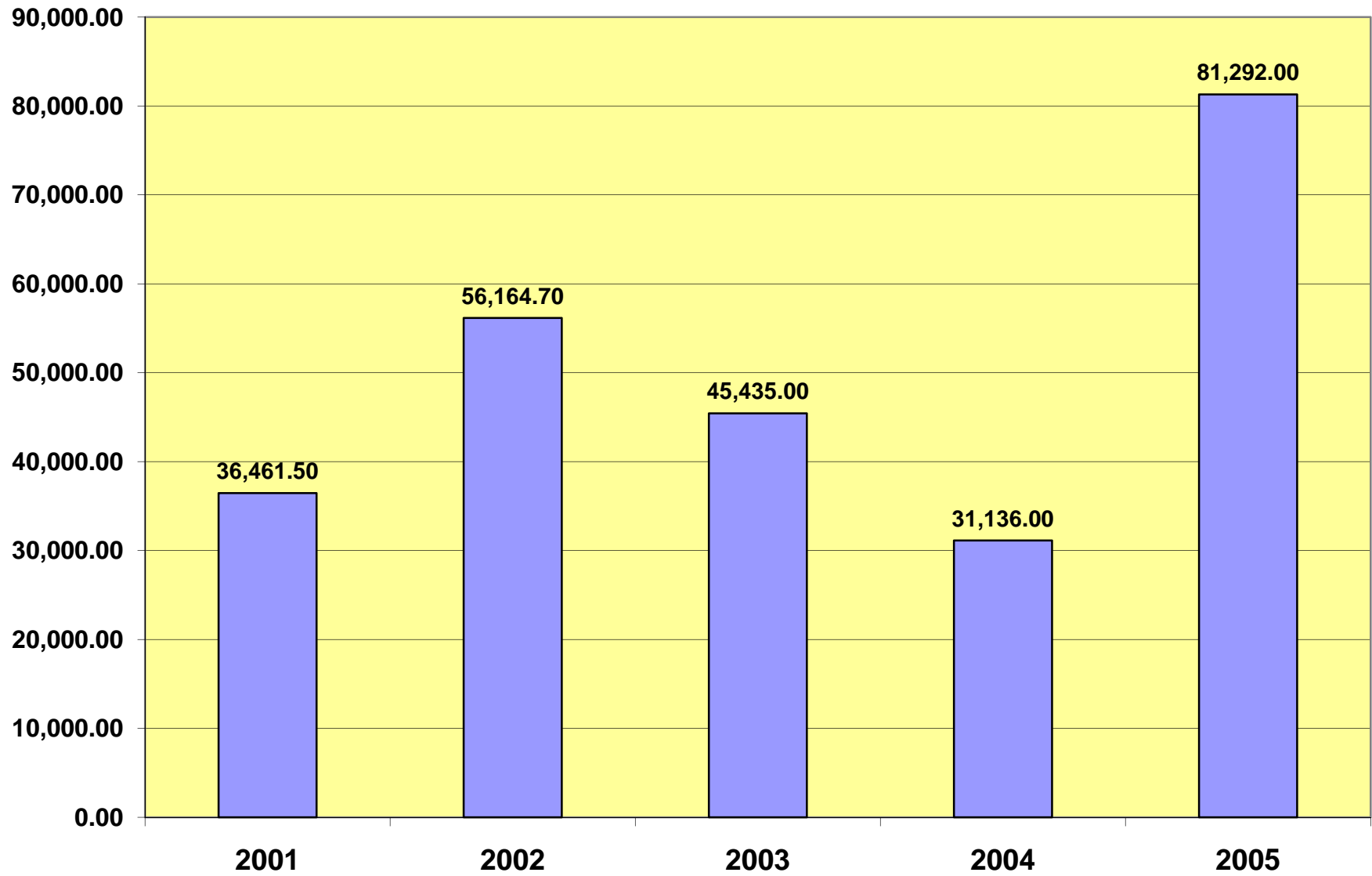
TOTAL BUILDING PERMIT REVENUE OF PERMIT FEES 2001-2005



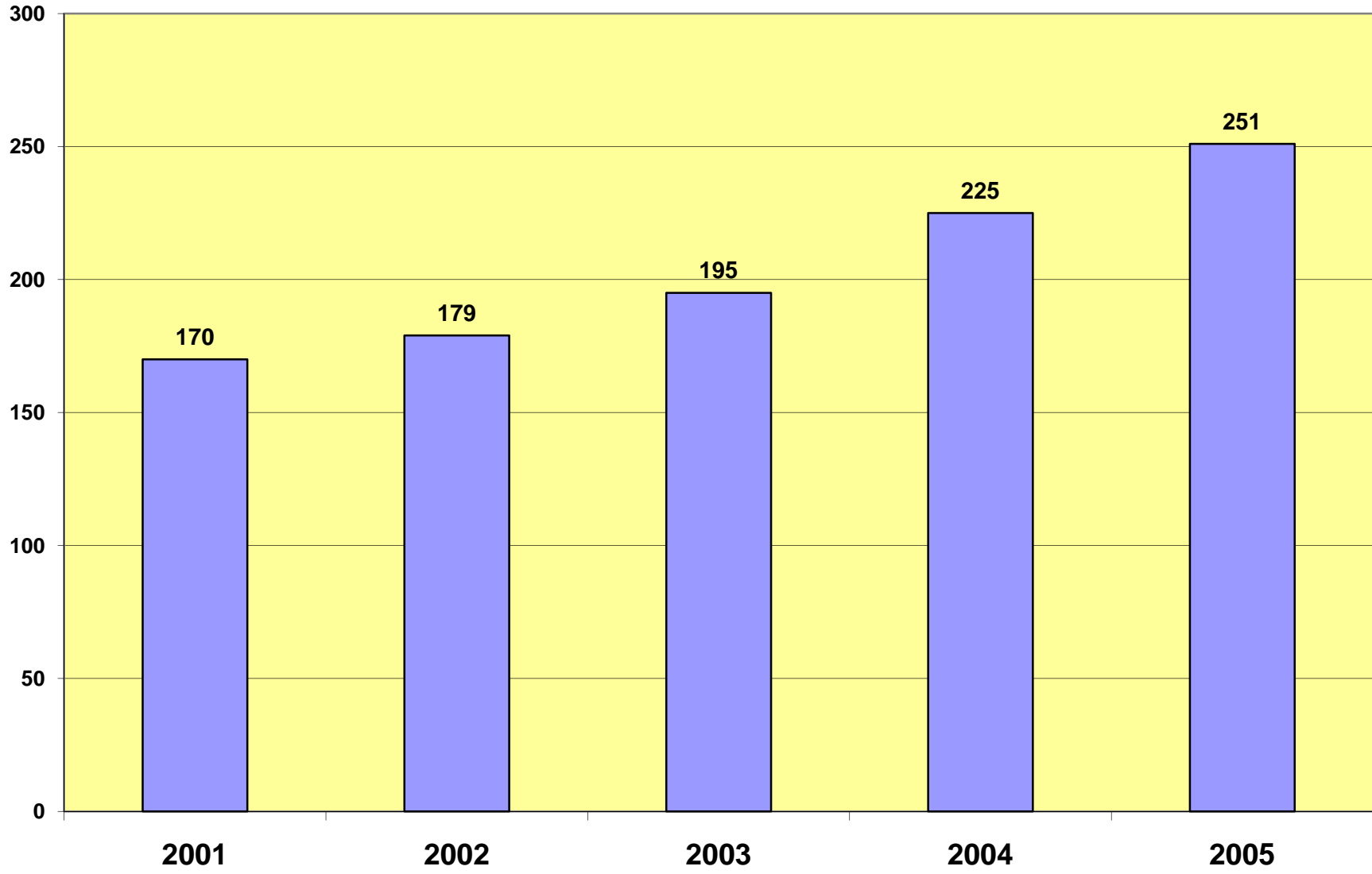
TOTAL NUMBER OF PLAN REVIEWS 2001-2005



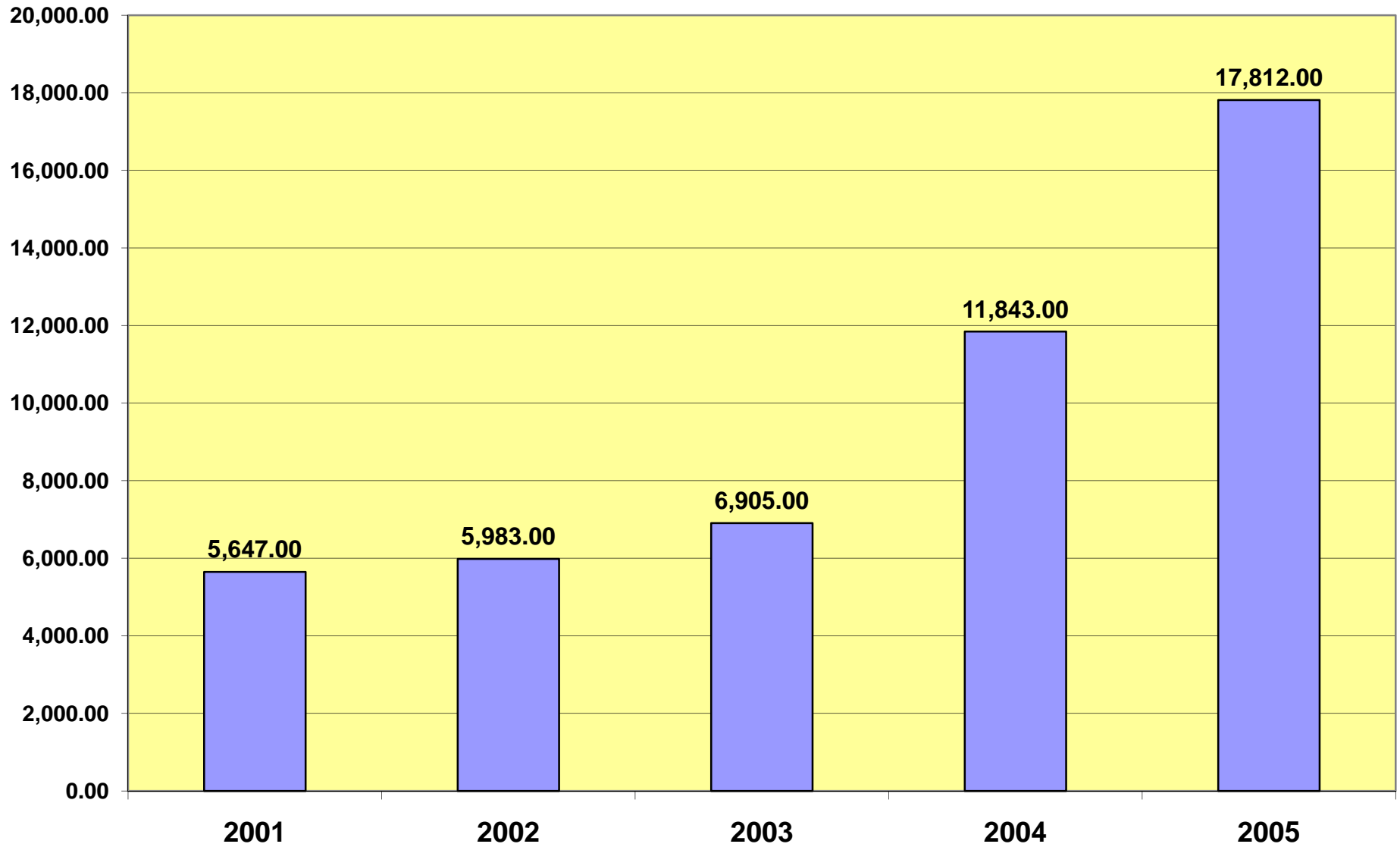
TOTAL PLAN REVIEW FEES 2001-2005



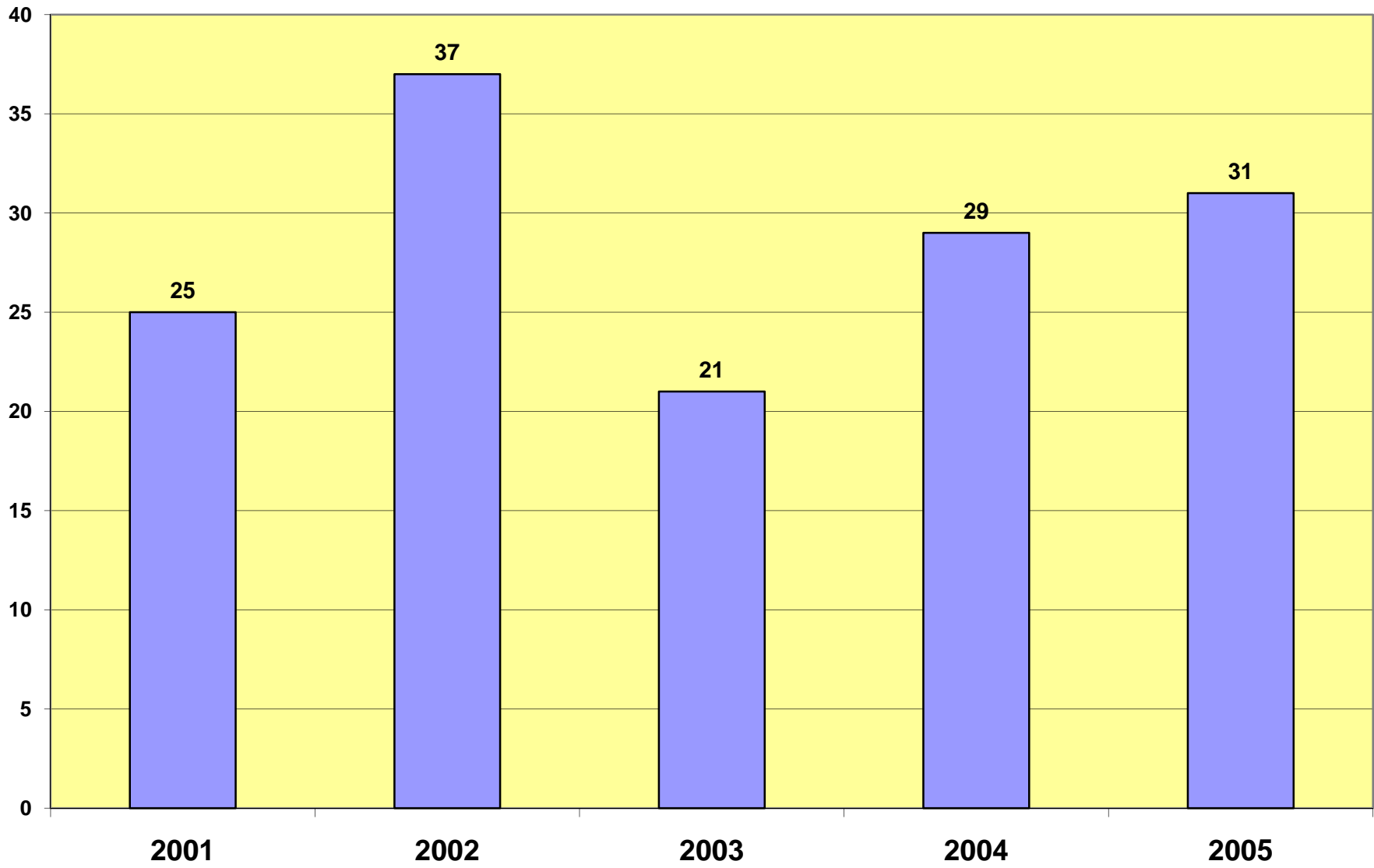
TOTAL NUMBER OF UTILITY PERMITS 2001-2005



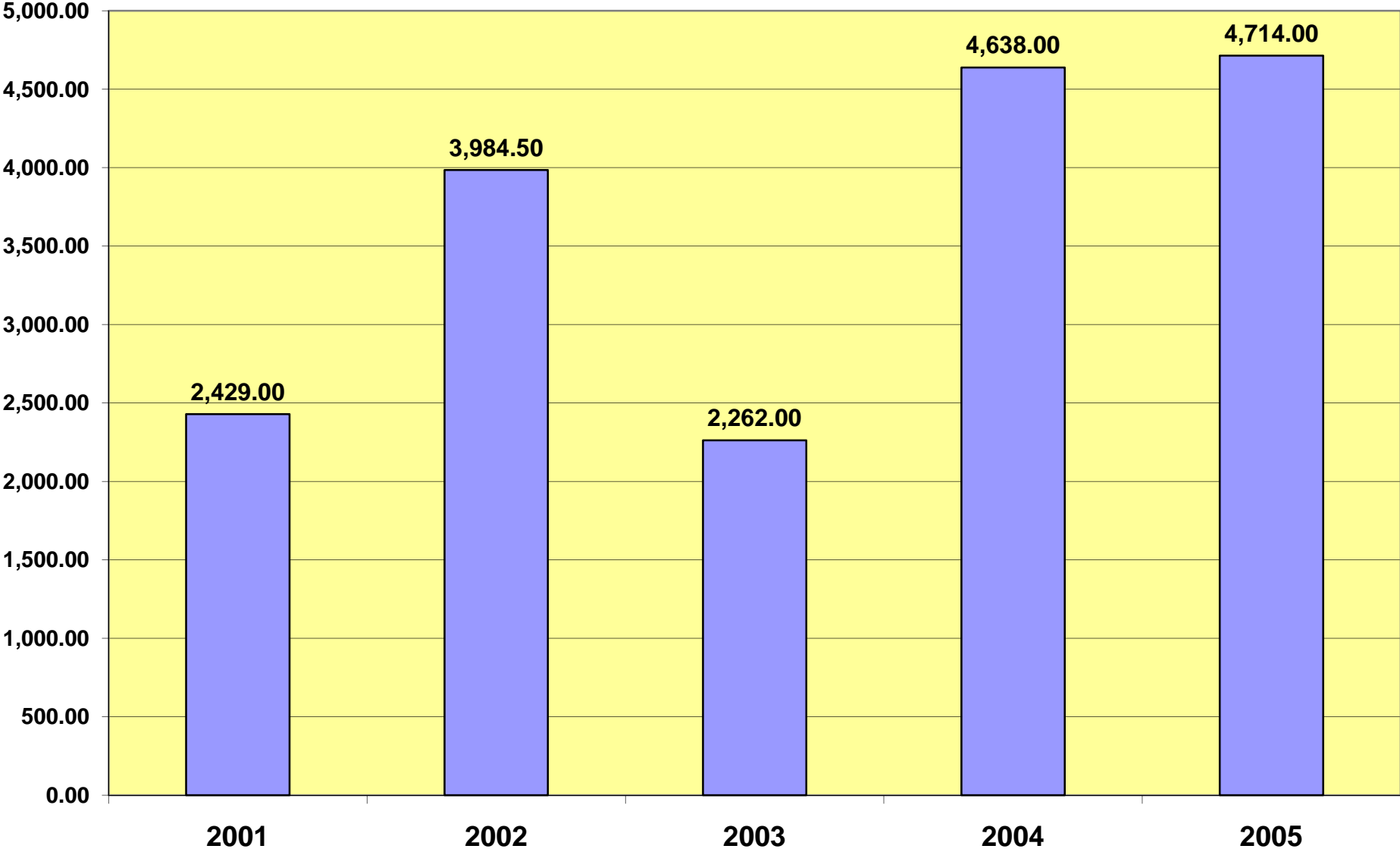
TOTAL UTILITY PERMIT FEES 2001-2005



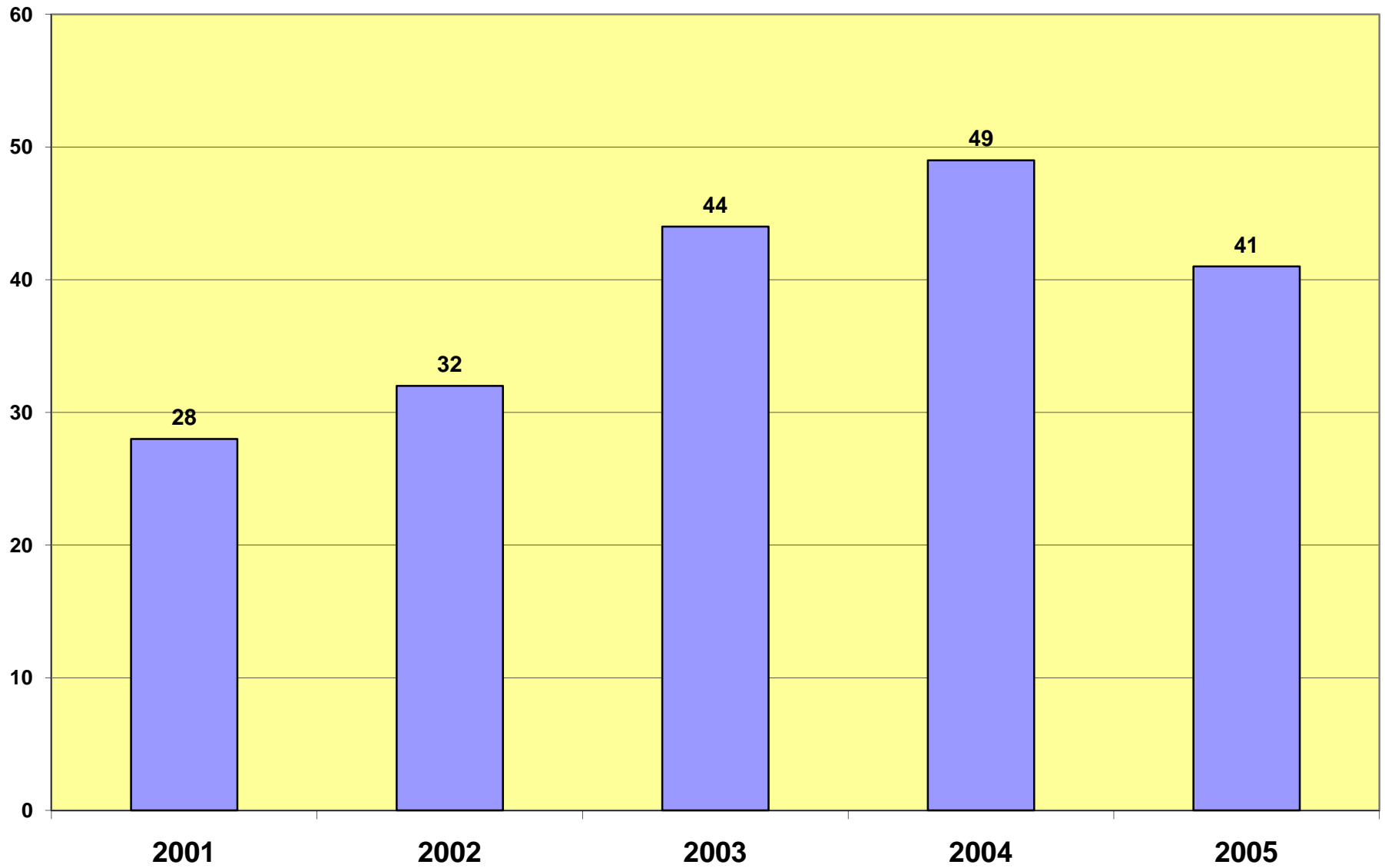
TOTAL NUMBER OF DEMOLITIONS 2001-2005



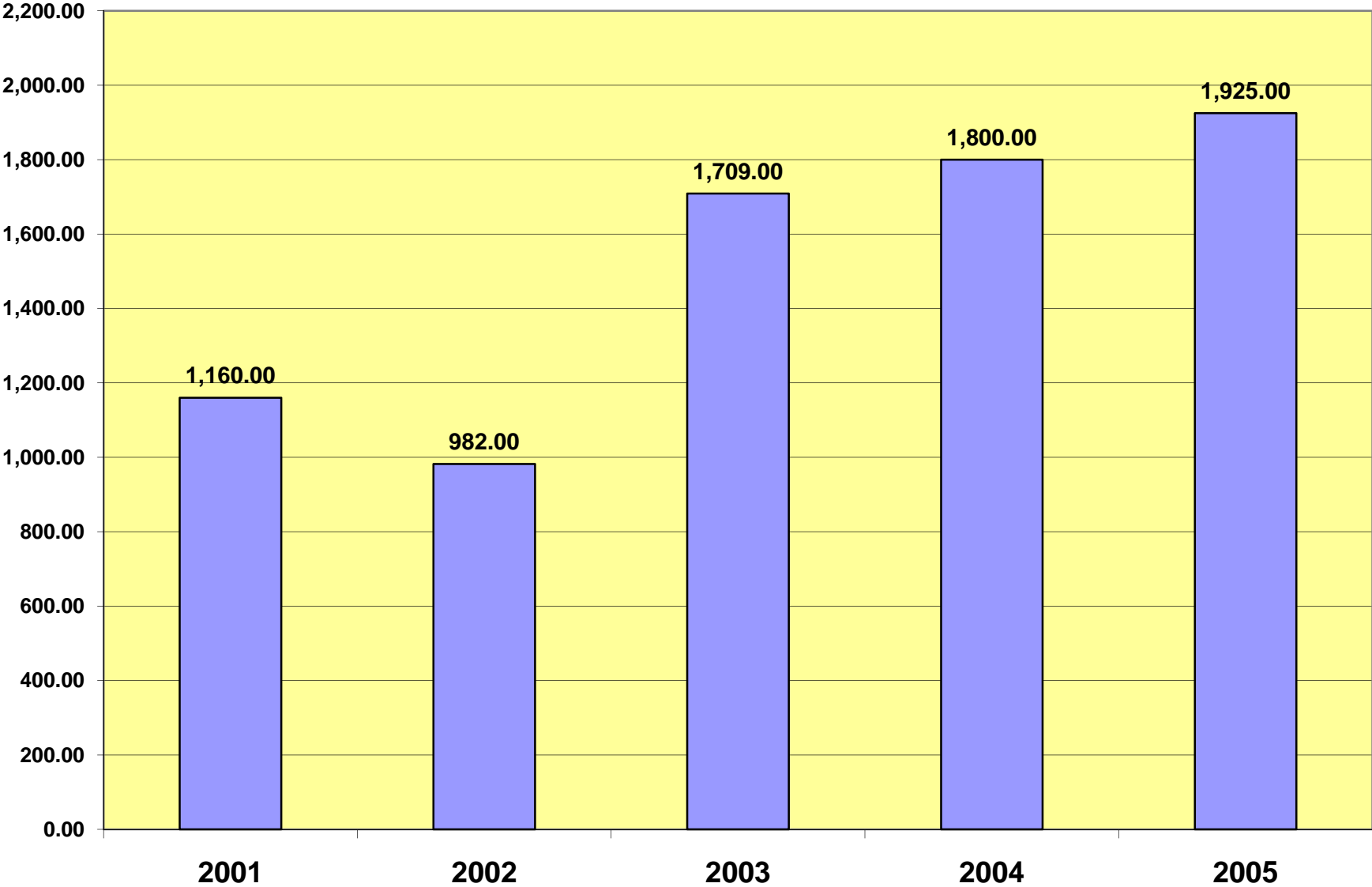
TOTAL DEMOLITION FEES 2001-2005



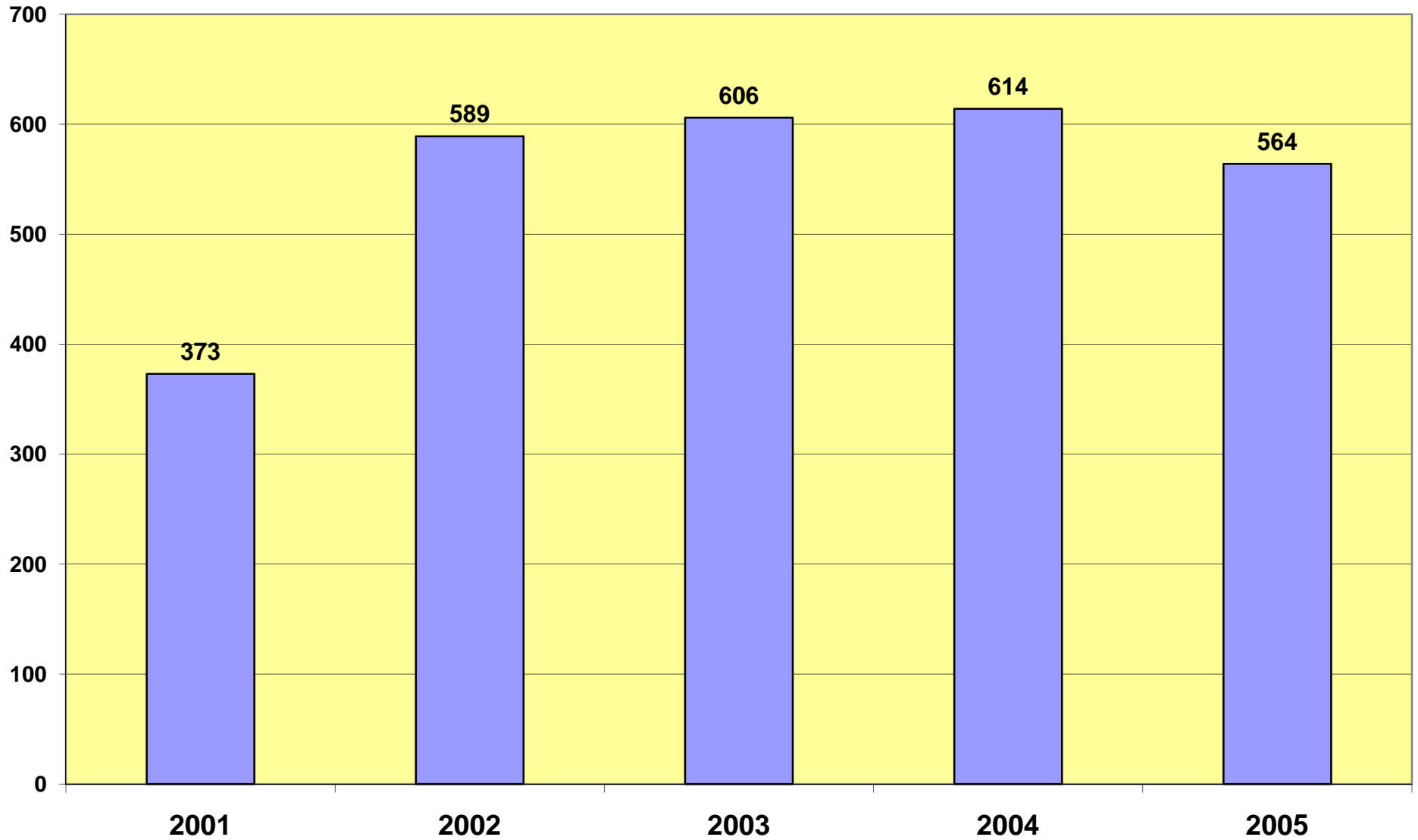
TOTAL NUMBER OF SIGN PERMITS 2001-2005



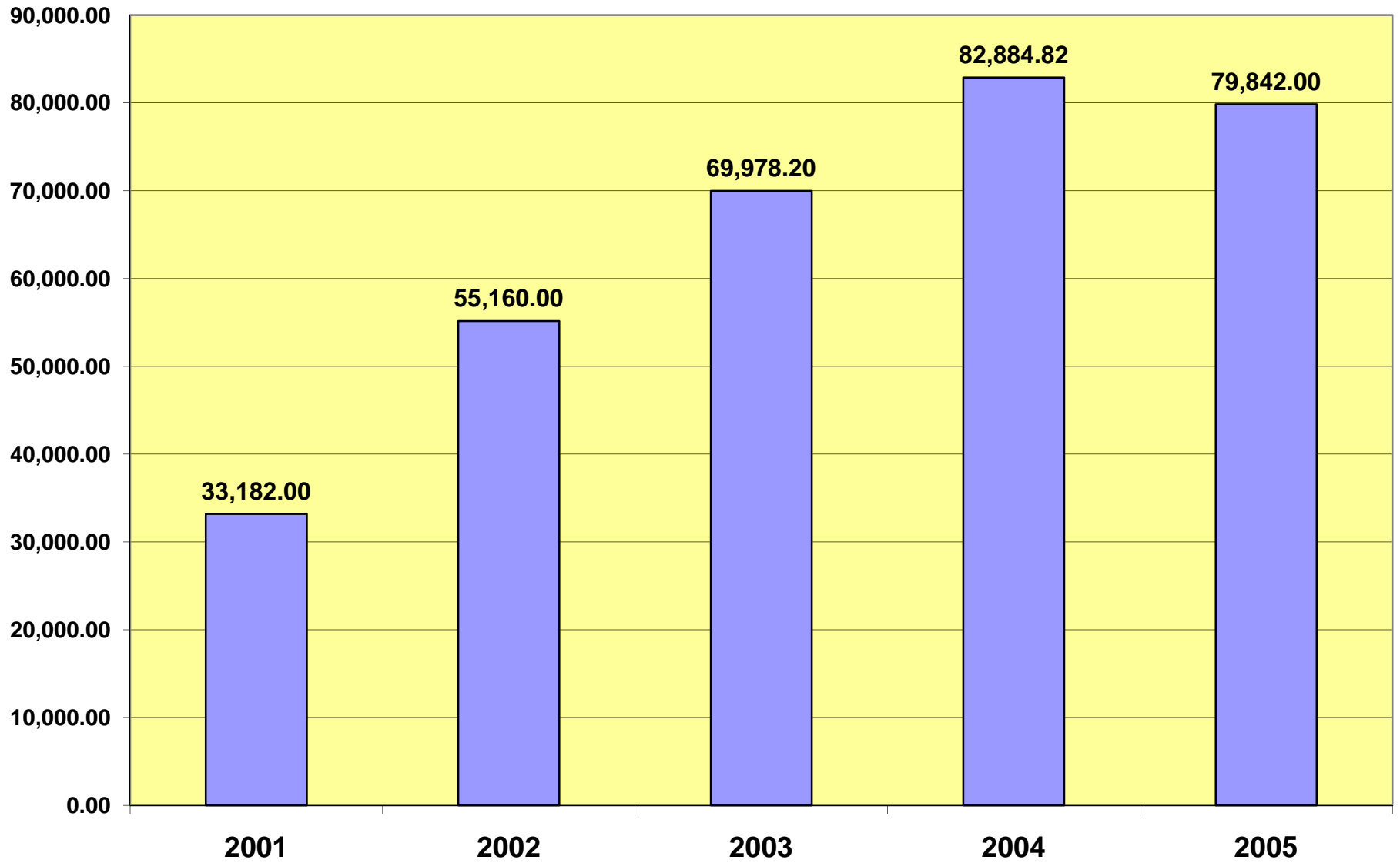
TOTAL SIGN PERMIT FEES 2001-2005



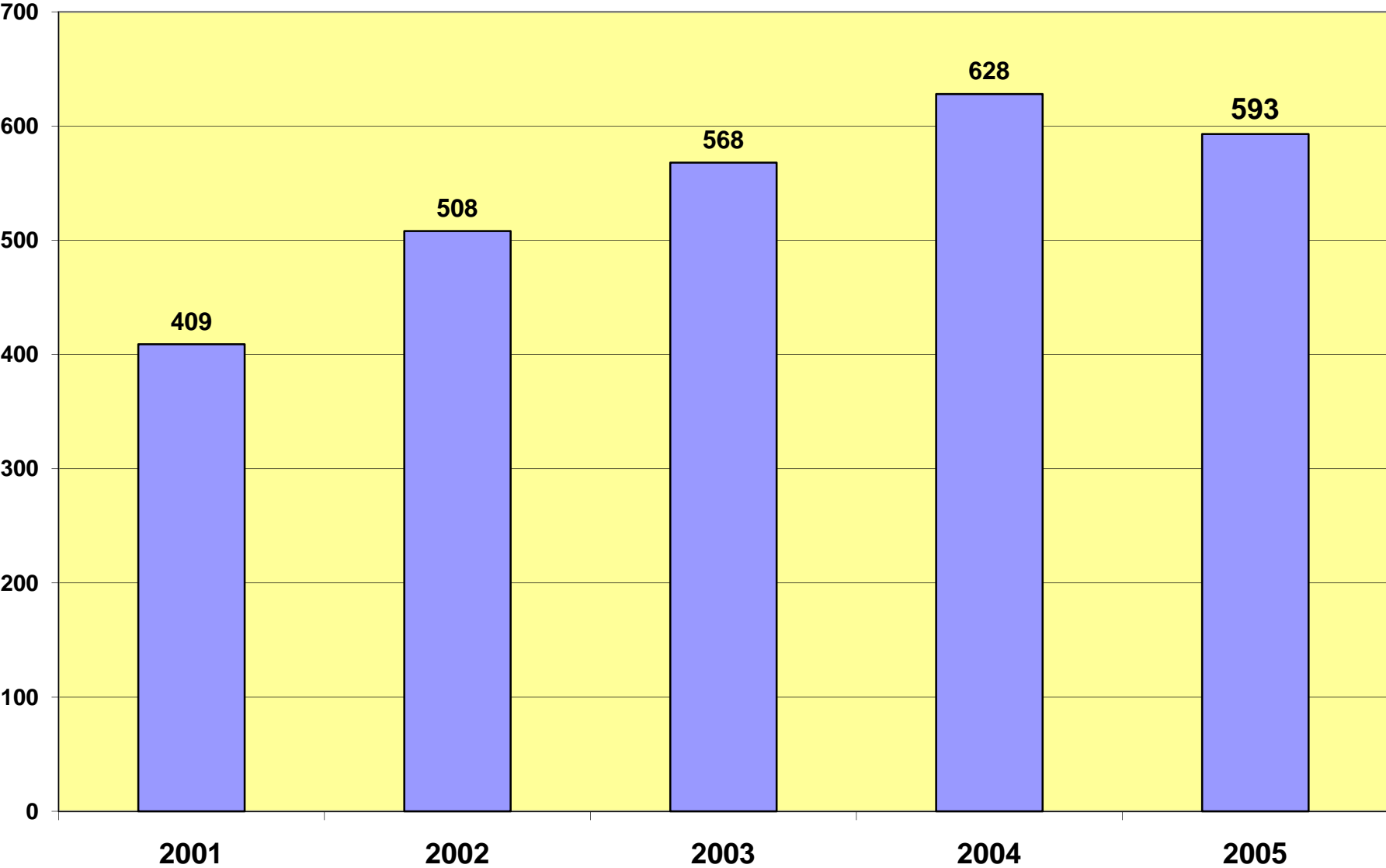
TOTAL NUMBER OF PLUMBING PERMITS 2001-2005



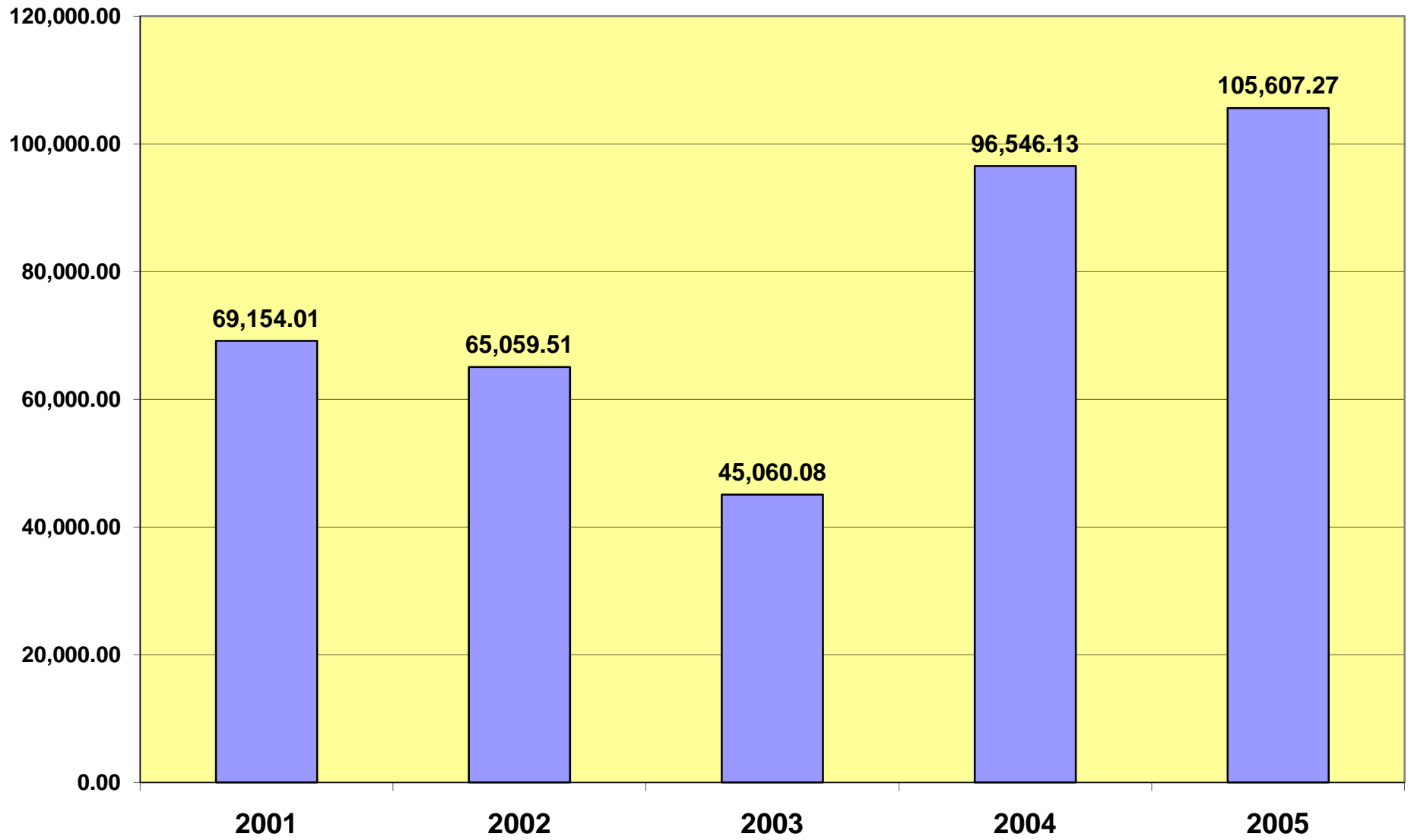
TOTAL PLUMBING PERMIT FEES 2001-2005



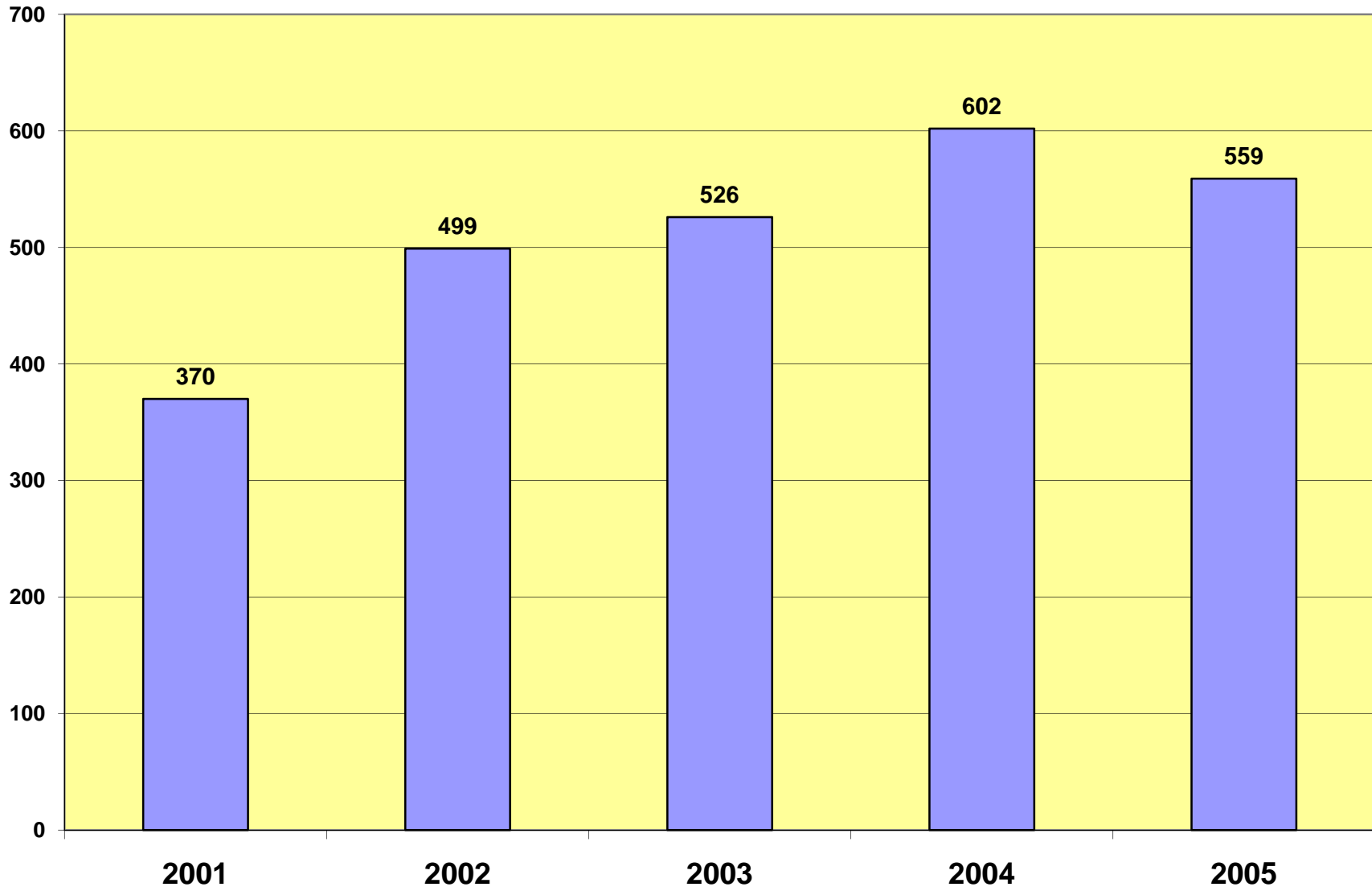
TOTAL NUMBER OF MECHANICAL PERMITS 2001-2005



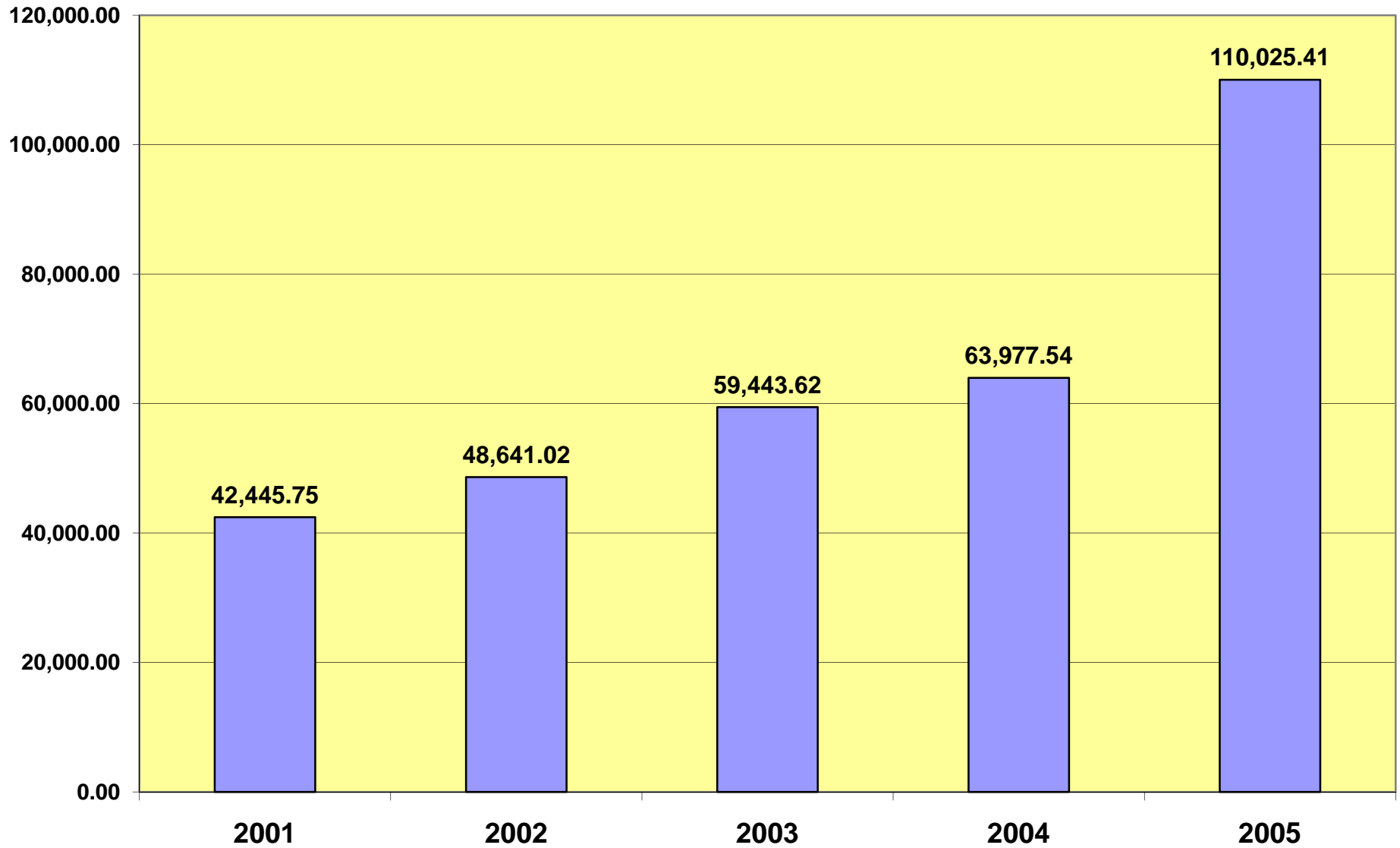
TOTAL MECHANICAL PERMIT FEES 2001-2005



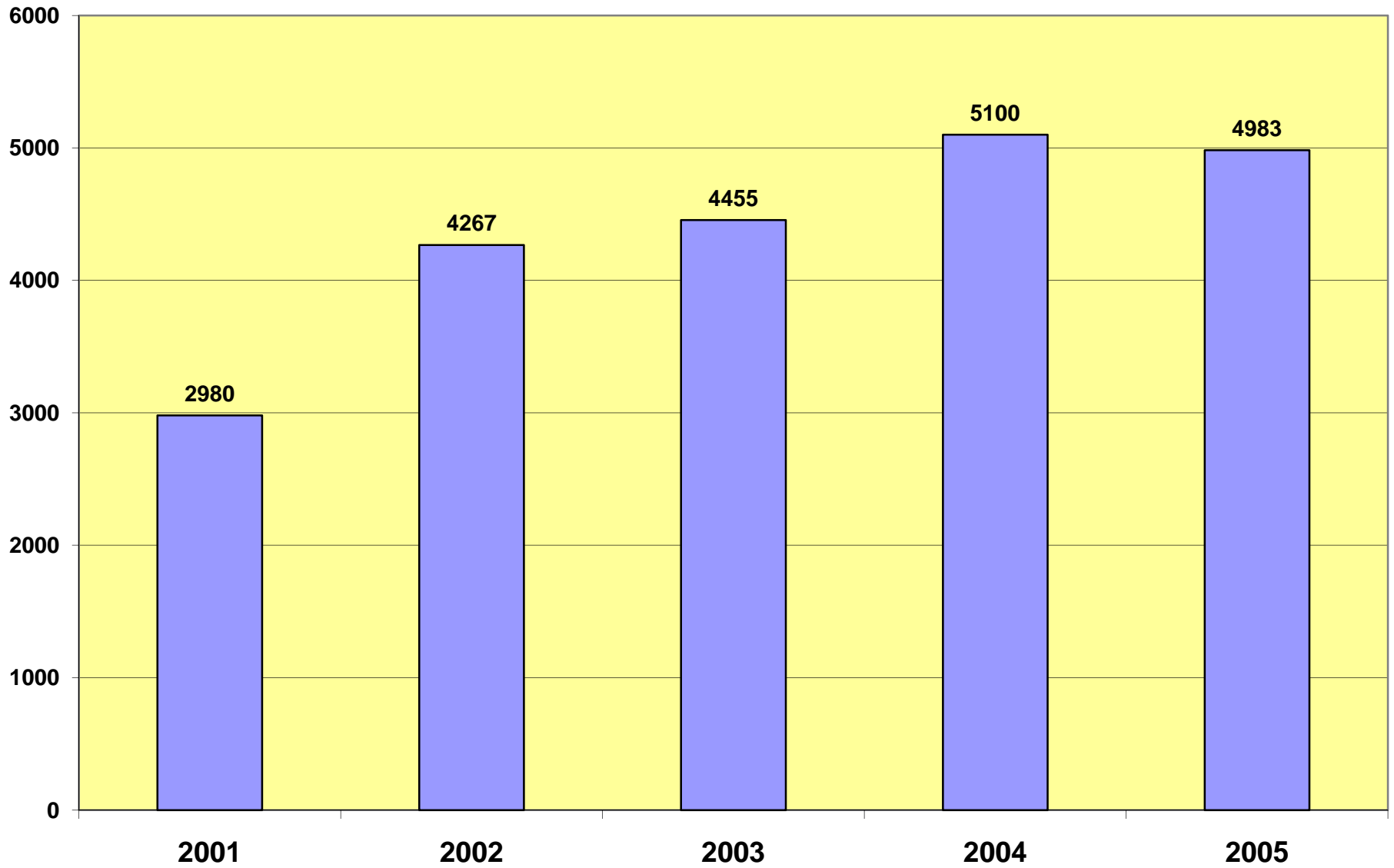
TOTAL NUMBER OF ELECTRICAL PERMITS 2001-2005
