**EMERGENCY ORDER NO. 21-01**

**RE-ISSUANCE OF EMERGENCY ORDER NO. 20-05**

**ALCOHOLIC LIQUOR – COCKTAILS “TO GO”**

Effective Date: Upon execution of this Emergency Order No. 21-01 by the Mayor.

**EXPLANATION:** This Emergency Order 21-01 (hereinafter, “Order”) provides for the Re-Issuance of Emergency Order 20-05 providing for certain liquor license holders to sell alcoholic liquor cocktails “to-go”.

**AUTHORITY TO ISSUE EMERGENCY ORDER:** Public Act 101-0631, which Governor Pritzker signed into law and became effective on June 2, 2020, and Public Act 102-0008, which Governor Pritzker signed into law and became effective on June 2, 2021. Such Public Acts do not limit Home Rule authority with regard to the provisions of such Public Acts.

**ISSUER OF EMERGENCY ORDER 21-01:** Diane Wolfe Marlin, Mayor.

Pursuant to Public Act 101-0631, Public Act 102-0008, and Ordinance Numbers 2020-03-015 and 2020-04-24, I, Diane Wolfe Marlin, Mayor and Local Liquor Commissioner of the City of Urbana, Illinois, do hereby issue the following Emergency Order 21-01.

1. Emergency Order 20-05, regarding Cocktails “To Go”, was effective on June 5, 2020, a copy of which is attached hereto and incorporated by reference herein. Emergency Order 20-05 authorized and allowed certain liquor license holders to sell cocktails “to go” under the provisions set forth in such Emergency Order.
2. Sections 1 through 5, inclusive, of Emergency Order 20-05 are hereby re-issued and effective upon execution of this Emergency Order.
3. Sole Discretion. It is within the sole authority and discretion of the Local Liquor Commissioner to approve, deny, suspend, revoke, or make conditional any activities permitted under this Emergency Order 21-01, in the interest of public health, safety or welfare.
4. Termination of this Emergency Order 21-01. This Emergency Order shall terminate upon the occurrence of one of the following: (i) the Mayor repealing this Emergency Order; (ii) the City Council repeals Ordinance Numbers 2020-03-015 and 2020-04-24; or (iii) the applicable provisions regarding the sale of cocktails “to go”, set forth in Emergency Order 20-05, are enacted into Chapter 3 of the Urbana City Code.
